A RESOLUTION ACCEPTING THE BIDS SUBMITTED BY GREEN VELVET SOD FARMS, SUNRISE, HELENA CHEMICAL, AND SITE ONE LANDSCAPE SUPPLY FOR CHEMICALS FOR THE GOLF CLUB AT YANKEE TRACE AND AUTHORIZING THE CITY MANAGER TO ENTER INTO CONTRACTS IN CONNECTION THEREWITH.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:



- C. **Helena Chemical Company** - **\$7,180.00** – 15gal of Proxy at \$480.00 20 gal of Mefenoxam at \$6,700.00
- D. **Site One** - **\$10,839.00** - 300 gal of Manicure Ultra at \$1,641.00 200 gal Lesco 18 Plus \$7,480.00 10 gal Spectator Ultra 1.3 \$488.00 15 gal Lesco Spectator T&O \$1,230.00

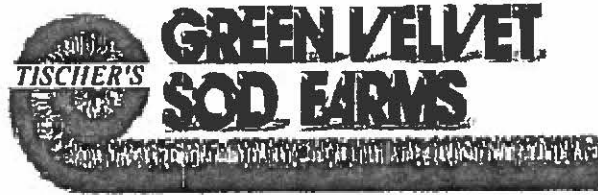


