A RESOLUTION ACCEPTING THE BIDS SUBMITTED BY GREEN VELVET SOD FARMS, JOHN DEERE LANDSCAPES, AND HELENA CHEMICALS FOR FERTILIZER FOR THE GOLF CLUB AT YANKEE TRACE AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN CONNECTION THEREWITH.

WHEREAS, the City of Centerville advertised for bidders for fertilizer for The Golf Club at Yankee Trace according to specifications prepared by the City, and

WHEREAS, Green Velvet Sod Farms, John Deere Landscapes, and Helena Chemicals were the lowest and best bidders on various products.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the following bids totaling \$27,317.06 are hereby accepted for fertilizers for The Golf Club at Yankee Trace, are marked as Exhibits "A," "B," and "C" are attached hereto and made a part hereof:

- A. **Green Velvet Sod Farms** – \$8,006.90 – 502 bags of 12-0-3 .15% Dimension 25%SCU sgn 215 at \$8,006.90.
- B. **John Deere** - \$15,322.66 – 280 bags of Merit .2% 14-0-0 20% Polyplus at \$4,886.00; 380 bags 24-3-12M 80% Polyplus 1Fe at \$8,362.66; 305 gallons of Iron + Chelated Zn at \$2,074.00.
- C. **Helena Chemicals** - \$3,987.50 – 250 bags of 30-0-10 50% PCSCU slow release at \$3,987.50.

Section 2. The City Manager is hereby authorized and directed to enter into any necessary contracts to evidence acceptance of said bids and to make payment pursuant thereto.
