Section 2. That the City Manager is hereby authorized to expend up to an additional \$42,000.00 to expand crack sealing and utilize remaining budgetary funds if extra work becomes necessary, making the total amount approved \$558,900.30.

Section 3. That the City Manager is hereby authorized to do all things necessary to execute a contract with Barrett Paving Materials, Inc., as stated above.
