NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:



**AMENDMENT TO CITY MANAGER AGREEMENT**

This Agreement entered into at Centerville, Ohio, on the \_\_\_\_ day of April, 2015, by and between the City of Centerville, an Ohio municipal corporation (hereinafter "City") and Gregory B. Horn (hereinafter "City Manager").

**WITNESSETH:**

**WHEREAS**, by Resolution No. \_\_\_\_\_, passed by a majority vote of all members of the Council of the City of Centerville on the 20<sup>th</sup> day of April, 2015, the CITY MANAGER AGREEMENT dated January 16, 1995, authorized by Resolution 1-95 and Resolution 82-97 and as amended as authorized by Resolution 48-98, Resolution 39-03, Resolution 67-05, Resolution 44-09, Resolution 51-11, and Resolution 54-13, is hereby authorized to be amended in accordance with the provisions below; and

**WHEREAS**, the parties wish to amend Section 1 of said Agreement;

**NOW THEREFORE**, in consideration of the foregoing recitations and pursuant to the terms of Resolution No. \_\_\_\_\_, the parties agree as follows with the matter to be omitted shown by ~~strike-out~~ and the new matter shown by *italics*:

**Section 1.** That effective May 1, 2014, Section 1 of said Agreement is amended as follows:

That portion of Section 1 of said Agreement and its amendments which specifies length of term and term commencement and expiration shall be changed to provide an extension of the ending date to read as follows: "the period of employment shall be for a term . . . ending on the ~~31<sup>st</sup>~~ 30<sup>th</sup> day of

~~December 2015~~ April 2016". In all other respects Section 1 shall remain in full force as written.

**Section 2.** That in all other respects said existing CITY MANAGER AGREEMENT, as amended is hereby ratified and restated as if fully rewritten herein.
