# **EXTENSION POLICY**

It is not necessary to file your Federal Extension by April 18, 2017 to extend the time to file your Centerville income tax return. A copy of the Federal Extension MUST be provided when filing your extended return on or before October 15th. An extension is of time to file only; not an extension of time to pay. Penalty and interest will be charged on taxes paid after April 18, 2017.

- Federal Form 1040, Page 1 must be attached to the return
- The return must be signed
- · Refund of less than \$10.00 will not be issued
- Tax due of less than \$10.00 is not payable
