THE CITY MANAGER TO ENTER INTO A
CONTRACT IN CONNECTION THEREWITH.

WHEREAS, the City of Centerville advertised for bidders for the
Yankee Trace Main Irrigation Lake Dredging Project, according to specifications

WHEREAS, PohlKat, Inc. was the low and best bidder.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY
RESOLVES:

Section 1. That the bid submitted by PohlKat, Inc. of Sidney, Ohio, with a bid
price of \$10.30 per cubic yard of silt removal, and \$3,000 for restoration, for a total
project cost of \$200,200, is hereby accepted, a copy of which is attached hereto,
incorporated herein and marked as Exhibit "A".

Section 2. That the City Manager is hereby authorized to do all things
necessary to execute a contract with PohlKat, Inc., as stated above.

Section 4. That this resolution shall take effect on the earliest date allowed by
law.
