WHEREAS, the City of Centerville advertised for bidders for the  
purchase of golf carts for The Golf Club at Yankee Trace according to

WHEREAS, Lake Erie Golf Cars, LLC was the low and best  
bidder.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE  
HEREBY  
RESOLVES:

Section 1. That the bid submitted by Lake Erie Golf Cars, LLC, be and is  
hereby accepted for the purchase of 100 golf carts at a bid price of \$410,000 with  
a trade-in of \$157,500 for 90 of the City's existing carts, for a net purchase price  
of \$252,500, a copy of which is attached hereto and incorporated herein, marked  
as Exhibit "A".

Section 2. That the City Manager is hereby authorized to do all things  
necessary to execute a contract with Lake Erie Golf Cars, LLC, for the purchase  
of 100 golf carts with a trade-in of 90 existing carts owned by the City of  
Centerville.

Section 3. This resolution becomes effective at the earliest date allowed  
by law.


