A RESOLUTION ACCEPTING THE BID SUBMITTED BY AMERICA'S DECORATIVE CONCRETE, LLC OF GREENVILLE, OHIO FOR THE CITY OF CENTERVILLE'S 2011 CONCRETE PROGRAM: HANDICAP ACCESSIBILITY RAMPS, SIDEWALK REPAIR, NEW SIDEWALK, AND RTA BUS STOP ACCESSIBILITY AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN CONNECTION THEREWITH.

WHEREAS, the City of Centerville was awarded Community Development Block Grant funds (\$70,000) for Handicap Accessibility Ramp Improvements, and

WHEREAS, the City of Centerville was awarded New Freedom funds (80% federal - 20% local, maximum of \$25,344.00 federal match) through the Federal Transit Administration as solicited by the Miami Valley Regional Planning Commission for RTA Bus Stop Accessibility, and

WHEREAS, the City of Centerville advertised for bidders for the 2011 Concrete Program: Handicap Accessibility Ramps, Sidewalk Repair, New Sidewalk, and RTA Bus Stop Accessibility, according to specifications prepared by the City, and

WHEREAS, America's Decorative Concrete, LLC, of Greenville, Ohio, was the low and best bidder.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the bid submitted by America's Decorative Concrete of Greenville, Ohio for the 2011 Concrete Program: Handicap Accessibility Ramps, Sidewalk Repair, New Sidewalk, and RTA Bus Stop Accessibility in the City of Centerville, is hereby accepted in the amount of \$161,720.00. The City Manager is hereby authorized to expend up to an additional \$41,000 to fully expend the budgeted City and CDBG funds for Handicap Accessibility Ramp Improvements,

for contingencies during the project. The maximum total amount approved is \$202,720.00.

Section 2. That the City Manager is hereby authorized and directed to do everything necessary to evidence acceptance of said bid and to make payment pursuant thereto.

Section 3. This resolution shall become effective at the earliest date allowed by law.
