**A RESOLUTION AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE, ON BEHALF OF THE CITY OF CENTERVILLE, TO SUBMIT AN APPLICATION FOR FEDERAL AMERICAN REINVESTMENT AND RECOVERY ACT OF 2009 FUNDS TO THE MIAMI VALLEY REGIONAL PLANNING COMMISSION FOR ROADWAY IMPROVEMENT PROJECTS.**

WHEREAS, the Miami Valley Regional Planning Commission (MVRPC) has solicited local government entities to submit new transportation projects for funding consideration in the SFY 2008-2011 Transportation Improvement Program; and

WHEREAS, the City of Centerville has committed to a timely project development schedule; and

WHEREAS, the City of Centerville has committed the necessary resources to support the local cost portion of the project; and

WHEREAS, the City Manager has recommended that application be made to the MVRPC for the following projects, as stated in order of priority:

1. Resurface the Bigger Road roadway surface beginning at the City's north corporation line at Hewett Road to State Route 725 (approximately 5,400 linear feet), including repair and replacement of deteriorated curb and storm sewer repair and asphalt resurfacing.
2. Refurbish the State Route 48 bridge superstructure across Interstate Route 675 in the City of Centerville Ohio.
3. Resurface the Clys Road roadway surface beginning at Bigger Road to Wilmington Pike (approximately 5,000 linear feet of roadway), including repair and asphalt resurfacing, and repair and replacement of deteriorated curb and storm sewer.
4. Refurbish the Bigger Road bridge superstructure over Interstate Route 675 in the City of Centerville Ohio.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:


Section 1: That the City Manager or his designee is hereby authorized to submit an application to the MVRPC for funding consideration in the SFY 2008-20011 Transportation Improvement Program for funding for the following transportation projects, in the following priority:

1. Resurface the Bigger Road roadway surface beginning at the City's north corporation line at Hewett Road to State Route 725 (approximately 5,400 linear feet), including repair and replacement of deteriorated curb and storm sewer repair and asphalt resurfacing.
2. Refurbish the State Route 48 bridge superstructure across Interstate Route 675 in the City of Centerville Ohio.
3. Resurface the Clyo Road roadway surface beginning at Bigger Road to Wilmington Pike (approximately 5,000 linear feet of roadway), including repair and asphalt resurfacing, and repair and replacement of deteriorated curb and storm sewer.
4. Refurbish Bigger Road bridge superstructure over Interstate Route 675 in the City of Centerville Ohio.
