A RESOLUTION DECLARING SPECIFIC VEHICLES

WHEREAS, equipment and vehicles no longer needed for use by City personnel may be
declared as surplus property.

RESOLVES:

Section 1. That the property outlined in Exhibit "A," attached hereto and made a part
hereof, is hereby declared as surplus property, and the City Manager is hereby authorized and
directed to offer said property for public auction or dispose of said property in accordance with
Chapter 212 of the Centerville Municipal Code.
