hereby authorized to do all things necessary to execute a contract with
Everybody's Workplace Solutions for said project.

Section 2. That the City Manager is hereby authorized to expend up to an
additional \$2,711.00 (5% of the bid price) for unknown and contingency items in
accordance with unit prices quoted in the bid submitted by Everybody's
Workplace Solutions.
