necessary to execute a contract with Bell Equipment of Ohio for the purchase of one
knuckle boom grapple loader and trailer in accordance with the City's advertised
specifications.

The signer of this proposal, as bidder, declares that he/she has carefully examined the Notice to Bidders and Specifications contained herein and agrees that if the proposal is accepted, he/she will enter into a contract with the City of Centerville to provide the equipment described.

Each bid shall be accompanied by a certified check or bid bond in the amount of ten (10) percent of the bid price to insure that in the event the bid is accepted, a contract will be entered into and the performance properly secured.

The City of Centerville reserves the right to reject any and all bids, to waive any irregularities in any bid, to hold any bid fifty (50) days before accepting same, or accept that bid which in the judgment of the City of Centerville is in the best interest of the City. The City reserves the right to accept or reject the proposed trade-in allowance for the unit described below. Bids may be awarded with or without trade and the City may retain the trade-in unit. 
