A RESOLUTION ACCEPTING THE BID SUBMITTED BY GREEN VELVET SOD FARMS, TURFGRASS, INC. AND LESCO, INC. FOR THE PURCHASE OF FERTILIZER FOR THE GOLF COURSE AT YANKEE TRACE AND TO AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT IN CONNECTION THEREWITH.

WHEREAS, Green Velvet Sod Farms, Turfgrass Inc. and LESCO, Inc., were the low and best bidders.


NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

- **Turfgrass Inc., \$5,781.00**, for the purchase of the following:  
**Fertilizer** - (Garys Green 18-3-4+ Iron) (A.O.K.)
- **LESCO, INC., \$20,243.00**, (Merit.2% 19-0-19 50% ppscu) Sub for FFII, (PCNB 12.5% 10-3-23 40% PPSCU), (15-0-0+ Iron)  
**Public Works Department, \$1,525.00** (14-14-14 poly plus)(20-20-20+ micros)(16-32-16).


