A RESOLUTION ACCEPTING THE BIDS SUBMITTED BY GREEN VELVET SOD FARMS, TURFGRASS SOUTH, INC, AND LESCO FOR THE PURCHASE OF CHEMICALS FOR THE GOLF CLUB AT YANKEE TRACE AND TO AUTHORIZE THE CITY MANAGER TO ENTER INTO CONTRACTS IN CONNECTION HERewith.

WHEREAS, the City of Centerville advertised for bidders for the purchase of chemicals for The Golf Club at Yankee Trace according to specifications prepared by the City, and

WHEREAS, Green Velvet Sod Farms, Lesco, and Turfgrass South, Inc., were the lowest and best bidders.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the following bids be and are hereby accepted for chemicals for the Golf Club at Yankee Trace, marked as Exhibit "A" attached hereto and made a part hereof:

Green Velvet Sod Farms, \$19,550.00, for the purchase of Tartan and Subdue.

Turfgrass South, \$14,695.00, for the purchase of Primo Max, Sevin SL, 26 GT, and Teremec SP.

Lesco, \$18,262.12, for the purchase of Daconil (substitution), Instrata (substitution), Concert (substitution) and Quick Silver.

Section 2. The City Manager is hereby authorized and directed to enter into any necessary contracts to evidence acceptance of said bids and to make payment pursuant thereto.

Section 3. This resolution becomes effective upon its adoption.
