A RESOLUTION AUTHORIZING THE CITY OF CENTERVILLE TO PARTICIPATE IN THE ODOT COOPERATIVE PURCHASING PROGRAM.

WHEREAS, Ohio Revised Code Section 5513.01 (B) provides the opportunity for Counties, Townships, Municipal Corporations, Conservancy Districts, Township Park Districts created under Chapter 1545 of the Revised Code, Port Authorities, Regional Transit Authorities, Regional Airport Authorities, Regional Water and Sewer Districts, County Transit Boards, State Universities or Colleges to participate in contracts of the Ohio Department of Transportation for the purchase of machinery, material, supplies or other articles.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

SECTION 1. That the City Manager hereby requests authority in the name of the City of Centerville to participate in the Ohio Department of Transportation contracts for the purchase of machinery, materials, supplies or other articles which the Department has entered into pursuant to Ohio Revised Code Section 5513.01 (B).

SECTION 2. That the City Manager is hereby authorized to agree in the name of the City of Centerville to be bound by all terms and conditions as the Director of Transportation prescribes.

SECTION 3. That the City Manager is hereby authorized to agree in the name of the City of Centerville to directly pay vendors, under each such contract of the Ohio Department of Transportation in which the City of Centerville participates, for items it receives pursuant to the contract.

SECTION 4. That the City of Centerville agrees to be responsible for resolving all claims or disputes arising out of its participation in the cooperative purchasing program under Section 5513.01 (B) of the Ohio Revised Code. The City of Centerville releases and forever discharges the Director of Transportation and the Ohio Department of Transportation from all such claims, actions, expenses, or other damages arising out of its

participation in the cooperative purchasing program which the City of Centerville may have or claim to have against ODOT or its employees, unless such liability is the result of negligence on the part of ODOT or its employees.				
SECTION 5. That this Resolution becomes effective upon adoption.
