

RESOLUTION NO. 28-06

SPONSORED BY COUNCILMEMBER Paul Gresham ON THE
5th DAY OF June, 2006.

A SERVICE RESOLUTION IN SUPPORT OF THE PROPOSED ANNEXATION OF PROPERTY CONTAINING 94.987 ACRES MORE OR LESS FROM SUGARCREEK TOWNSHIP, GREENE COUNTY, OHIO TO THE CITY OF CENTERVILLE, MONTGOMERY COUNTY, OHIO PURSUANT TO THE REQUIREMENT OF SECTION 709.023 OHIO REVISED CODE.

WHEREAS, a petition has been filed requesting annexation to the City of Centerville of 94.987 acres, more or less, of land in Sugarcreek Township, Greene County, owned by Dille Laboratories Corp., and

WHEREAS, the Ohio Revised Code requires that a municipal legislative authority shall, within twenty days from the date of the filing of the petition seeking annexation, by ordinance or resolution, to state what services, if any, the municipal corporation will provide to the territory proposed for annexation upon annexation, and an approximate date by which it will provide the services.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. Upon annexation to the City of Centerville, Ohio of the territory proposed for annexation, the City of Centerville will provide full-time police protection, police crime prevention, street maintenance, snow and ice removal, new street construction, traffic control, traffic signalization as necessary, engineering services, code enforcement, waste collection, cultural arts, zoning, building inspection and planning services. The services will be available and will be provided when the City of Centerville's ordinance or resolution accepting the annexation becomes final as provided by law. The approximate date of providing the services is December 1, 2006. If a street or highway will be divided or segmented by the boundary line between the township and the municipal corporation so as to create a road maintenance problem, the City of Centerville agrees as a condition of the annexation to assume the maintenance of that street or highway or to otherwise correct the problem.

Section 2. The Clerk is hereby directed to prepare a certified copy of this Resolution and have it filed with the Greene County Board of County Commissioners prior to the Commissioners' annexation review as required by law.
