Description

Poles and Fixtures:

Install 26 Vimont II Colonial Style Lantems (Manufactured by Unique Solutions) on 12 foot Hamilton Series Cast Aluminum Poles (Manufactured by Unique Solutions).

The poles will be manufactured and installed with external GFI protected electrical outlets mounted near the top of the pole. The above fixtures will be installed including 150 watt HPS color corrected lamps. At the City's request the poles will be set back 24" from the back of the curb. There are several locations where the base of the pole will extend into the sidewalk.

Restoration: DPLE will bore to new light locations and restore bore holes with seed and straw.

The City will be responsible for watering.

Ownership:

The City will maintain ownership of poles, concrete bases and light fixtures. DPLE will maintain ownership of the electric distribution system and photoelectric control units.

Energy and Maintenance:

DPLE will provide energy and routine maintenance for the lights in accordance with the DPLE street lighting agreement. Routine maintenance includes repairs to the electric system, bulb, lens, photo-cell replacement, and periodic relamping of fixture. Other maintenance is quoted on time and material basis.

There will be an additional cost for the energy associated with the GFI outlets. This cost is to be determined.
