A RESOLUTION AUTHORIZING THE CITY MANAGER TO PARTICIPATE IN A CONTRACT WITH THE DEPARTMENT OF ADMINISTRATIVE SERVICES, OFFICE OF STATE PURCHASING FOR THE PURCHASE OF SEVERAL VEHICLES FOR THE CITY OF CENTERVILLE IN ACCORDANCE WITH ORDINANCE NUMBER 19-88.

Section 2. That the City of Centerville directly pay the vendor for said vehicles, under state contract.
