RESOLUTION NO. 25-02
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER Roger W. Krass ON THE 17th
DAY OF June, 2002.

THE FINAL RESOLUTION TO COOPERATE WITH THE
STATE OF OHIO, DEPARTMENT OF TRANSPORTATION
FOR THE RESURFACING OF STATE ROUTE 725
(ALEXANDERSVILLE-BELLBROOK ROAD) FROM
BIGGER ROAD TO THE GREENE/MONTGOMERY
COUNTY LINE.

The following Final Resolution enacted by the City of Centerville, Ohio, hereinafter referred to as the Legislative Authority/Local Public Agency or "LPA", in the matter of the stated described project.

WHEREAS, on the 18th day of June, 2001, the LPA enacted legislation proposing cooperation with the Director of Transportation for the described project:

Two lane resurfacing of existing roadway and other roadway related items, lying within the City of Centerville. Total work length of project being approximately 0.97 miles; and

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The City agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement, less the amount of State funds set aside by the Director of Transportation for the financing of this improvement, and further, the City agrees to assume and bear the entire cost of the installation and/or repair of curb ramps within the resurfacing limits of the project, which are necessary to ensure compliance with the Americans with Disabilities Act.

In addition, the City also agrees to assume and bear one hundred percent (100%) of the cost of any construction items requested by the City on the entire improvement, which are not necessary for the improvement, as determined by the State and Federal Highway Administration.

The share of the cost of the LPA is now estimated in the amount of **Twenty Nine Thousand Nine Hundred and - - - - 00/100 Dollars, (\$29,900.00)**, but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and

WHEREAS, The Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, The LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

SECTION 1. That the estimated sum of **Twenty Nine Thousand Nine Hundred and - - - -00/100 Dollars, (\$29,900.00)**, is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from State funds.

SECTION 2. That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

SECTION 3. That the LPA enter into a contract with the State, and that the **City Manager** be, and is hereby authorized to execute said contract, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.

SECTION 4. That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.

SECTION 5. That this Resolution be effective immediately upon passage.
