A RESOLUTION AUTHORIZING THE CITY MANAGER TO PARTICIPATE IN A CONTRACT WITH THE DEPARTMENT OF ADMINISTRATIVE SERVICES, OFFICE OF STATE PURCHASING FOR THE PURCHASE OF A BACKHOE AND RELATED EQUIPMENT FOR THE CITY OF CENTERVILLE IN ACCORDANCE WITH ORDINANCE NUMBER 19-88.

WHEREAS, Ordinance Number 19-88, passed by the Council of the City of Centerville, Ohio, on the 16<sup>th</sup> day of January, 1989, authorized the City of Centerville to participate in contracts of the State of Ohio, Department of Administrative Services, Office of State Purchasing for the purpose of purchasing supplies, services, equipment and certain materials; and

WHEREAS, the Department of Administrative Services, Office of State Purchasing has entered into a contract with Southeastern Equipment Company, Inc. for the purchase of certain equipment, in accordance with Section 125.04 of the Ohio Revised Code.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the City Manager be authorized to participate in a contract between the Department of Administrative Services, Office of State Purchasing and Southeastern Equipment Company, Inc. for the purchase of one backhoe and related equipment for the total bid price of \$57,092.14, a copy of which is attached hereto and marked as Exhibit "A".

Section 2. That the City of Centerville directly pay the vendor for said equipment, under State contract.

Section 3. That this Resolution become effective immediately upon passage.
