A RESOLUTION ACCEPTING THE APPLICATION OF YANKEE TRACE DEVELOPMENT, INC. FOR THE ANNEXATION OF TERRITORY.

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the application of Yankee Trace Development, Inc., for the annexation of the following described territory:

Situate in Section 5, Town 2, Range 5 M.Rs., Washington Township, Montgomery County, Ohio being part of the 29.602 acre tract conveyed to Yankee Trace Development, Inc. by deed recorded in Microfiche Number 99-386D01 of the Deed Records of Montgomery County, Ohio and being a tract of land more particularly described as follows:

Beginning at a point in the centerline of Washington Church Road at the northwest corner of Andree Plat, recorded in Plat Book 65, Page 35 of the Plat Records of said County, said corner also being a corner of said 29.602 acre tract; thence from said point of beginning in a northerly direction with the centerline of Washington Church Road and the east line of Miami Township and the east line of Section 11, Town 2, Range 5 M.Rs. a distance of 77.0 feet, more or less, to the southwest corner of the 0.966 acre tract conveyed to Barton Isaacs and Tammy Isaacs by deed recorded in MF #98-564D08;
