

RESOLUTION NO. 41-01
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER Paul Giresheim ON THE 30th
DAY OF April, 2001.

A RESOLUTION AUTHORIZING THE CITY MANAGER TO NEGOTIATE A CONTRACT WITH QUALITY GOLF, INC. OF SUNBURY, OHIO FOR THE CONSTRUCTION OF A GOLF COURSE ADDITION AT THE CITY'S MUNICIPAL GOLF COURSE WHICH CONTRACT SHALL BE IN AN AMOUNT EQUAL TO OR LESS THAN THE BID SUBMITTED BY QUALITY GOLF, INC. AT THE BID OPENING WHICH OCCURRED ON APRIL 17, 2001.

WHEREAS, the City duly advertised for bids for the construction of six additional golf holes to be constructed at the City's golf course at Yankee Trace; and

WHEREAS, Quality Golf, Inc. of Sunbury, Ohio was the low bidder but said bid exceeded the engineer's estimate; and

WHEREAS, the City Council is of the opinion that it is in the best interests of its citizens to authorize the City Manager to negotiate a construction contract for said project with Quality Golf, Inc. by making some deducts in order to lower the price if same can be accomplished; and

WHEREAS, the City of Centerville as a charter municipality with full home rule powers as provided in Article XVIII, Section 3 of the Ohio Constitution has the power and authority to authorize the City Manager to follow the procedure provided for herein.

NOW THEREFORE,

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the City Manager is hereby authorized to negotiate a contract for the construction of six additional golf holes to be constructed at the City's golf course at Yankee Trace with Quality Golf, Inc. in an amount and upon such terms as he deems advisable upon the condition that the contract amount may not exceed \$1,863,411.00, the amount of the bid submitted by Quality Golf, Inc. on April 17, 2001.
