

RESOLUTION NO. 73-01
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER Douglas Clue ON THE
17th DAY OF September, 2001.

A RESOLUTION OF SUPPORT FOR THE PROPOSED AUSTIN ROAD
INTERCHANGE, WHICH IS CURRENTLY BEING STUDIED AS AN
I-75 CONNECTOR IN SOUTHERN MONTGOMERY COUNTY.

WHEREAS, Interstate 75 is the major north/south freeway serving Montgomery County; and

WHEREAS, State Route 725 continues to experience increased traffic congestion, and transportation planners predict that highway traffic will continue to increase over the next decade; and

WHEREAS, Interstate 675 was constructed in the 1980's to relieve traffic congestion on I 75 and resulted in an increase in development in eastern Montgomery County;

WHEREAS, representatives of the Economic Development Committee attended meetings addressing the Austin Road interchange, conducted extensive deliberations, held educational forums for benefit of Chamber members, and communicated directly with members; and

WHEREAS, Chamber members believe the Austin Road interchange will improve highway infrastructure, mitigate traffic congestion, improve air quality, strengthen the Miami Valley region, including the city of Dayton and Montgomery County, be a positive benefit for the business community, positive benefit for the residential community and positive benefit for traffic safety; and

WHEREAS, Chamber members recognize the value of agricultural community, comprehensive planning and sustainable growth, and believe the Austin Road interchange must be designed and positioned to minimize impact on the agricultural community.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY
RESOLVES TO:

Section 1. Endorse the need to expedite the Austin Road interchange to completion by: Separating Austin Road from State Route 892 and expedite construction of the Austin Road interchange; endorse the establishment of a Montgomery County Transportation Improvement District to support the expedited construction of the Austin Road interchange; and communicate this resolution to Montgomery County Commissioners, City of Dayton Commissioners, Miami Valley Regional Planning Commission, OKI MPO and the State of Ohio.
