A RESOLUTION RECOGNIZING A MORAL OBLIGATION OF THE CITY AND AUTHORIZING THE PAYMENT OF THREE THOUSAND DOLLARS (\$3,000.00) TO HUBERT ABNEY.

WHEREAS, the City Council has determined that the City has no legal obligation to make a financial contribution to Hubert Abney to assist in correcting a storm water drainage problem but it wishes to recognize a moral obligation; and

WHEREAS, said determination is based upon the legal advice from its Municipal Attorney; and

WHEREAS, said decision and instruction are consistent with the law of the State of Ohio; and

WHEREAS, this City has full Home Rule powers as set forth in its Charter and in §3, Article XVIII of the Constitution of Ohio and hereby invokes same in the passage of this resolution.

NOW THEREFORE,

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the City of Centerville is hereby authorized to make payment to Hubert Abney in the amount of Three Thousand Dollars (\$3,000.00) in recognition of a moral obligation as stated above on the condition that said Hubert Abney and all other parties with a property interest in the real property located at 728 Chipplegate Dr., Centerville, Ohio execute(s) and deliver(s) to the City a full and final release of all claims relating to the existing storm water drainage problem in such form as is acceptable to the Municipal Attorney.

It is further understood and agreed that the payment of up to \$3,000.00 for the correction of a storm water drainage problem is not to be considered as an admission on the part of said City or its agents of any liability whatsoever and that this payment is in recognition of a moral obligation by the City only.

I now state that the only consideration for my signing this Agreement is the correction of the storm water drainage problem as stated above; that no other promise or agreement of any kind or nature has been made with me by said City or its agents to cause me to sign this Agreement, and that I fully understand the meaning and intent of this instrument.
