A RESOLUTION IN SUPPORT OF THE PROPOSED ANNEXATION OF PROPERTY CONTAINING 10.640 ACRES MORE OR LESS FROM WASHINGTON TOWNSHIP, MONTGOMERY COUNTY, OHIO TO THE CITY OF CENTERVILLE, MONTGOMERY COUNTY, OHIO PURSUANT TO THE REQUIREMENTS OF REVISED SECTION 709.031 (B) OHIO REVISED CODE.

WHEREAS, Centerville has received a notice from the agent for the petitioners that a hearing on a Petition to Annex 10.640 acres more or less from Washington Township, Montgomery County, Ohio to the City of Centerville has been set for hearing before the Board of County Commissioners of Montgomery County on the 12th day of February, 2002; and

WHEREAS, said section of the Ohio Revised Code requires that, upon receiving said notice, a municipal legislative authority shall, by ordinance or resolution, adopt a statement indicating what services, if any, the municipal corporation will provide to the territory proposed for annexation upon annexation; and

WHEREAS, the City of Centerville is ready, willing and able to provide a superior level of service to the territory proposed for annexation upon annexation as well as other commitments and assurances to the petitioners.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. Upon annexation to the City of Centerville, Ohio of all or any part of the territory proposed for annexation, the City will provide, pursuant to the Ohio Constitution and laws of the state of Ohio, City Charter and Ordinances and policies of the City of Centerville, full-time police protection, police crime prevention, tornado disaster alert system, street maintenance, snow and ice removal, new street construction, traffic control, traffic signalization as necessary, planning and zoning, engineering services, code enforcement, waste collection, recreation and cultural arts, and all other services that the City of Centerville currently provides to the area within its current boundaries. Fire and paramedic service to the area is provided by the Centerville-Washington Township area fire department and would not change upon annexation. The City of Centerville will provide the same level of services to the territory

proposed for annexation as the services it provides to the area currently located within the corporate boundaries of the City of Centerville.

Section 2. The City will provide to the territory, if annexed, all of the services that are now provided or will be provided to Centerville properties and its residents. Based on the current review, the City has adequate staff and financial resources to meet all reasonable service needs of the territory to be annexed now and as it may develop in the future. The city will add such additional personnel and equipment necessary to provide a continuing full range of City services as the need may arise in the future.

Section 3. City Council hereby authorizes the City Manager, Department Directors and City staff to provide such testimony, affidavits, information and support for the annexation as necessary.

Section 4. The Clerk is hereby directed to prepare a certified copy of this Resolution and have it filed with the Montgomery County Commissioners prior to the annexation hearing as required by law.
