

RESOLUTION NO. 55-00
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER Roger W. Kraas ON THE 18th
DAY OF December, 2000.

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE A CONTRACT WITH WIFFENBACH MARBLE & TILE COMPANY TO PURCHASE CARPETING AND CARPET PADDING FOR \$79,360.00.

WHEREAS, the City followed its normal competitive bidding procedure to secure bids for carpet installation at the clubhouse at the Golf Course at Yankee Trace; and

WHEREAS, only two bids were received by the City and one of said bids was not responsive to the bid specifications in that the bidder submitted a bid for loop carpeting whereas the bid specifications required bids for the installation of cut pile and loop carpet; and

WHEREAS, the Wiffenbach Marble & Tile Company offered to supply pattern carpet to be Harbinger "Maderno" and solid carpet to be Harbinger "Plateau - Seaweed" and to meet an installation date of the last two weeks of January, 2001 for \$79,360.00 which is acceptable to the City; and

WHEREAS, the City Manager in prior consultation with the Council at an open meeting work session called pursuant to §121.22, Ohio Revised Code discussed the purchase of said carpet and was instructed by the Council to execute a contract with said lowest responsive bidder for the carpet specified herein which carpet is hereby determined to be an approved substitute for that specified in the bidding process; and

WHEREAS, this Council hereby finds that further competitive bidding would not be in the best interests of the citizens of Centerville and would cause unnecessary interruption of operations at the clubhouse at the Golf Course at Yankee Trace;

NOW THEREFORE,

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the City Manager is hereby authorized to execute a contract with Weiffenbach Marble & Tile Company to purchase and install the carpeting herein

above described provided that said Weiffenbach Marble & Tile Company agrees to comply with all of the applicable terms and conditions set forth as a part of the bidding process above referenced and supplies an appropriate performance bond.
