pursuant to specifications prepared by the City; and


WHEREAS, White Allen Chevrolet was the low and best bidder.



SEALED BIDS will be received at the office of the City Manager, 100 West Spring Valley Road, Centerville, Ohio 45458, until 10:00 A.M., February 24, 1999, for a new dump truck in accordance with the attached Notice to Bidders and specifications. Bids will be opened at 10:00 A.M. in the Council Chambers.

The signer of this proposal, as bidder, declares that he/she has carefully examined the Notice to Bidders and Specifications contained herein and agrees that if the proposal is accepted, he/she will enter into a contract with the City of Centerville to provide the equipment described.

Each bid shall be accompanied by a certified check or bid bond in the amount of ten (10) percent of the bid price to insure that in the event the bid is accepted, a contract will be entered into and the performance properly secured.

The City of Centerville reserves the right to reject any and all bids, to waive any irregularities in any bid, to hold any bid thirty (30) days before accepting same, or accept that bid which in the judgment of the City Manager of Centerville is in the best interest of the City. The City reserves the right to accept or reject the proposed trade-in allowance for the unit described below. Bids may be awarded with or without trade and the City may retain the trade-in unit.
