Whereas, the City advertised for bidders for lawn care services for certain specified city properties during 1999 throughout the community, pursuant to specifications prepared by the City; and


Whereas, Buckeye Ecocare was the low and best bidder.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:




