CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER Douglas Cline ON THE 20th DAY  
OF September, 1999.

A RESOLUTION AUTHORIZING THE PURCHASE OF GOLF INVENTORY FROM YANKEE TRACE GOLF PROFESSIONAL PATRICK BAYLEY AS A PART OF THE FULLFILLMENT OF A PREVIOUS CONDITION OF HIS EMPLOYMENT.

WHEREAS, the City of Centerville (hereinafter "City") has negotiated the employment of Patrick Bayley (hereinafter "Bayley") as its Golf Professional at the Golf Club at Yankee Trace; and

WHEREAS, the Council hereby determines that said equipment is necessary to the successful operation of the Pro Shop at the Golf Course at Yankee Trace as required by Section 2921.42 (C)(1) Ohio Revised Code; and

WHEREAS, as a part of the negotiations of his employment prior to employment the City agreed to consider purchasing certain golf equipment owned by Bayley as described in Exhibit "A" attached to this Resolution and incorporated herein so that the contemplated transaction is the continuation of a course of dealing commenced prior to Bayley's employment by the City as contemplated by Section 2921.42 (C)(2), Ohio Revised Code; and

WHEREAS, the City has caused an independent appraisal of said equipment to be made by a disinterested golf professional and has been advised that same is being offered for sale to the City at prices that are either preferential to the City or the same as prices to similar customers in similar transactions as required by Section 2921.42(C)(3), Ohio Revised Code; and

WHEREAS, the Council hereby determines that this entire transaction has been conducted at arm's length as required by Section 2921.42 (C) (4) Ohio Revised Code; and


WHEREAS, therefore, the Council hereby determines that said contemplated transaction with Bayley is not prohibited by the provisions of Section 2921.42, Ohio Revised Code and would be a benefit to the City; and

NOW THEREFORE,


THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:


