

RESOLUTION NO. 55-99  
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER C Mark Nugseed ON THE 18th DAY  
OF October, 1999.

A RESOLUTION AUTHORIZING THE PURCHASE OF THIRTY-NINE  
REPLACEMENT MOTOROLA PORTABLE RADIOS WITHOUT  
COMPETITIVE BIDDING.

WHEREAS, the Centerville Police Department presently operates using Motorola STX  
portable radios; and

WHEREAS, the great majority of the Police Department radios in Montgomery county  
utilize Motorola portable radios; and

WHEREAS, the use of the Motorola radios will allow the City police department  
personnel to communicate with other communities in the area using the same make radios which  
will not be possible if the make of said radios is changed; and

WHEREAS, the only manufacturer capable of supplying the compatible portable radios  
is Motorola which this council hereby finds is the sole source of radio equipment which is  
compatible with other neighboring radio systems; and

WHEREAS, this council further finds that since Motorola is the sole source of compatible  
radio equipment, competitive bidding would be a useless act and would not benefit the City and  
its citizens; and

WHEREAS, Motorola is no longer providing support for the City's existing radios but will  
grant the City a trade in allowance of \$300.00 per unit resulting in a total purchase savings of  
\$11,100.00;

NOW, THEREFORE,

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the Police Department of the City of Centerville is hereby  
authorized to purchase the following described equipment without competitive bidding for the  
reason that Motorola is the sole source of radio equipment which is compatible with the existing  
radio equipment owned by the Centerville Police Department:
