SPONSORED BY COUNCILMEMBER J.V. Stone ON THE 15<sup>th</sup>  
DAY OF November, 1999.

A RESOLUTION ACCEPTING THE BID SUBMITTED BY E-Z-GO DIVISION OF TEXTRON, INC. FOR THE RENTAL AND PURCHASE OF GOLF CARTS FOR THE GOLF CLUB AT YANKEE TRACE IN THE CITY OF CENTERVILLE AND TO AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT IN CONNECTION THEREWITH.

WHEREAS, the City of Centerville advertised for bidders for the rental and purchase of golf carts for The Golf Club at Yankee Trace according to specifications prepared by the City, and

WHEREAS, the E-Z-GO Division of Textron, Inc. was the low and best bidder.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the bid submitted by E-Z-GO Division of Textron, Inc., be and is hereby accepted for the lease-to-own in three years of 80 E-Z-GO 36 volt carts at a total bid price of \$152,820.00 with the trade-in of the City's existing carts, a copy of which is attached hereto and incorporated herein, marked Exhibit "A".

Section 2. That the City Manager is hereby authorized to do all things necessary to execute a contract with E-Z-GO Division of Textron, Inc. for lease-to-own in three years with trade for 80 E-Z-GO 36 volt carts at a total financing bid price of \$56, 630.00 per year.

Section 3. That the City of Centerville reserves the right to utilize local bank financing rather than the financing offered through E-Z-GO if in fact it is in the best interest of the City.

Section 4. That this Resolution become effective immediately upon passage.
