A RESOLUTION CORRECTING RESOLUTION 2-98  
PASSED ON JANUARY 26, 1998 BY CITING THE  
CORRECT LEGAL AUTHORITY FOR COUNCIL'S  
ACTION.

WHEREAS, on January 26, 1998 the Council of the City of Centerville passed Resolution 2-98 to authorize the City Manager to purchase five 1998 Crown Victoria Patrol Cars from Stengers Ford as per specifications prepared by the State of Ohio, Department of Administrative Services, Office of State Purchasing; and

WHEREAS, said Resolution cited the Ohio Revised Code as authority for the purchase of supplies, services, equipment and certain materials from a local supplier if said purchase can be made at the same purchase price as was obtained through the State of Ohio, Department of Administrative Services, Office of State Purchasing which citation of authority was erroneous; and

WHEREAS, the City has participated in the said State of Ohio purchasing program on the authority contained in Ordinance 19-88 passed on January 16, 1989 which ordinance was passed based upon the authority contained in § 735.053 Ohio Revised Code; and

WHEREAS, the authority for the City to purchase supplies, services, equipment and certain materials from a local supplier if said purchase can be made at the same purchase price as was obtained through the State of Ohio, Department of Administrative Services, Office of State Purchasing is based upon the Home Rule powers of the City as contained in Article XVIII, § 3 of the Ohio Constitution; and

WHEREAS, the Council of the City of Centerville exercising its said Home Rule powers hereby determines that it is in the best interests of the citizens of Centerville for the Council to authorize the City Manager to purchase five 1998 Crown Victoria Patrol Cars from Stengers Ford as per specifications prepared by the State of Ohio, Department of Administrative Services, Office of State Purchasing.


NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:




