WHEREAS, the City of Centerville advertised for bidders for a 25 cubic yard, high compaction, refuse packer(s), complete with chassis and packer body, pursuant to specifications prepared by the City; and

WHEREAS, Crane Carrier Company was the low and best bidder.


NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the bid submitted by Crane Carrier Company for the purchase of a 25 cubic yard, high compaction, refuse packer(s) complete with chassis and Dempster packer body plus dual steering for the cab and chassis at a cost of \$112,845.00 per unit, less trade in(s), be and is hereby accepted, a copy of said bid marked Exhibit "A" attached hereto and made a part hereof, and that the City Manager be granted the option to purchase up to two (2) units.

Section 2. That the City Manager is hereby authorized and directed to enter into any necessary contract to evidence acceptance of said bid and to make payment pursuant thereto.

Section 3 This Resolution shall become effective at the earliest date allowed by law.
