

RESOLUTION NO. 14-98

SPONSORED BY COUNCILMEMBER C. MARK KINGSEED ON THE
20th DAY OF APRIL, 1998.

A RESOLUTION OBJECTING TO THE TRANSFER OF D5 AND D6 LIQUOR PERMITS FROM EMMA JEAN THOMAS DBA GASLIGHT LOUNGE, 877 EAST FRANKLIN STREET, CENTERVILLE, OHIO TO SOFT ROCK CAFÉ, INC. DBA SOFT ROCK CAFÉ; STATING THE REASONS THEREFORE AND REQUESTING A HEARING.

WHEREAS, the legislative authority of the City of Centerville, the Council of the City of Centerville has received a notice from the Ohio Division of Liquor Control that there is a request for transfer of existing D5 and D6 liquor permits from Emma Jean Thomas DBA Gaslight Lounge to Soft Rock Café, Inc. DBA Soft Rock Café for the business located at 877 East Franklin Street, Centerville, Ohio; and

WHEREAS, pursuant to said notice an investigation of the proposed transferee, its officers and sole shareholder was undertaken by the Centerville Police Department; and

WHEREAS, said investigation has revealed the chief executive officer and sole shareholder of the proposed transferee has a criminal record including felony arrests and convictions; has demonstrated alcohol and/or drug addiction; has demonstrated disorderly behavior and a lack of cooperation with law enforcement officers in the performance of their duties all of which the Council of the City of Centerville finds relates to his ability to operate a liquor establishment; and

WHEREAS, said investigation also revealed that another officer of the proposed transferee has been convicted of disorderly conduct which the Council of the City of Centerville finds relates to his ability to operate a liquor establishment.


NOW THEREFORE; THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the Council of the City of Centerville hereby objects to the proposed transfer of existing D5 and D6 liquor permits from Emma Jean Thomas DBA Gaslight Lounge to Soft Rock Café, Inc. DBA Soft Rock Café for business located at 877 East Franklin Street, Centerville, Ohio for the reasons stated above in the preamble of this

resolution:




