A RESOLUTION ACCEPTING THE APPLICATION OF YANKEE DEVELOPMENT GROUP FOR THE ANNEXATION OF TERRITORY.

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

<u>Section 1.</u> That the application of Yankee Development Group, for the annexation of the following described territory:

Situate in Section 5, Town 2, Range 5 M.R.s., Washington Township, Montgomery County, Ohio, being part of the 29.602 acre tract conveyed to Yankee Development Group by deed recorded in Microfiche Number 90-275A11 of the deed records of Montgomery County, Ohio and being more particularly described as follows:

Starting for reference at the southwest corner of Said Section 5; thence from said starting point in a northerly direction with the centerline of Washington Church Road a distance of 781.69 feet, more or less to the southwest corner of the 2.195 acre tract conveyed to Bruce T. and Julia K. Chamberlain by deed recorded in MF#87-709C06;

thence in an easterly direction with the south line of said 2.195 acre tract a distance of 500.00 feet to the southeast corner of said Yankee Development Group 29.602 acre tract, the True Point of Beginning for the herein described parcel to be annexed;

thence from said True Point of Beginning in a northerly direction with a west line of said 29.602 acre tract a distance of 400.00 feet to the northeast corner of the 2.195 acre tract conveyed to Otis W. Jr. & Anna M. Tipton by deed recorded in Deed Book 2021, Page 140; thence in a westerly direction with the north line of said 2.195 acre tract a distance of 100.00 feet to the southeast corner of the 1.316 acre tract conveyed to Walter D. and Joyce L. Dowden by deed recorded in D.B. 2133, Pg. 583;

thence in a northerly direction with the west line of said 29.602 acre tract a distance of 750.0 feet to the northeast corner of Andree Plat, recorded in Plat Book 65, Page 35 of the Plat Records of said County;

thence in a westerly direction with the north line of said Andree Plat a

distance of 384.3 feet, more or less to the east right-of-way line of Washington Church Road (said point being 15.00 feet east of the centerline of said road measured at right angles);

thence in a northerly direction with the east right-of-way line of Washington Church Road a distance of 77.00 feet, more or less to the north line of said 29.602 acre tract;

thence in an easterly direction with a north line of said 29.602 acre tract a distance of 384.3 feet, more or less to the southeast corner of the 0.966 acre tract conveyed to Theodore J. Poelking and Christine A. Henslee by deed recorded in MF#95-170C04;

thence in a northerly direction with the east line of said 0.966 acre tract a distance of 110.00 feet to the northeast corner of said tract;

thence in an easterly direction with the north line of said 29.602 acre tract a distance of 1038.0 feet, more or less to the northeast corner of said tract; thence in a southerly direction with the east line of said 29.602 acre tract and the existing City of Centerville Corporation line a distance of 1324.4 feet to the southeast corner of said 29.602 acre tract;

thence in a westerly direction with the south line of said 29.602 acre tract a distance of 888.5 feet, more or less to the True Point of Beginning,

containing 29.574 acres of land, more or less, to be annexed to the City of Centerville, Ohio, subject to all legal conditions, easements and rights-ofway of record.
