

RESOLUTION NO. 5-97  
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER JAMES SINGER ON THE 20th  
DAY OF JANUARY, 1997.

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY MANAGER TO PARTICIPATE IN A THE MONTGOMERY COUNTY, OHIO PROGRAM TO PURCHASE MCS MOBILE RADIOS WHICH ARE COMPATIBLE WITH THOSE USED BY THE MONTGOMERY COUNTY SHERIFF'S OFFICE AND A MTS PORTABLE RADIO WITH SECURE NET AND TO EXECUTE A CONTRACT WITH MOTOROLA FOR THE PURCHASE OF 13 MCS MOBILE UNITS, INSTALLATION AND WARRANTY AND 1 MTS PORTABLE RADIO WITH SECURE NET FOR A TOTAL COST NOT TO EXCEED \$24,881.00.

WHEREAS, Montgomery County, Ohio entered into public bidding for mobile radios which are compatible with those being presently used by the Montgomery County Sheriff's Office; and

WHEREAS, members of the Centerville Police Department can not now communicate with members of the Sheriff's Office by mobile radio because of the incompatibility of the equipment which inability creates security problems for the citizens served by both departments; and

WHEREAS, City Council finds that the low bid for said equipment submitted by Motorola was the lowest and best bid;

NOW THEREFORE,

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the City Manager is hereby authorized and directed to execute any and all documents necessary in order to carry out the purposes of this Resolution for the purchase of 13 MCS Mobile Radios including 3 year warranties and installation and to purchase 1 MTS Portable Radio with secure net, for a total amount not to exceed \$24,881.00.
