WHEREAS, the City of Centerville advertised for bidders for the demolition project at 155 West Spring Valley Road pursuant to specifications prepared by the City; and


WHEREAS, John P. Raisch, Inc., was the low and best bidder.


Section 2. That this Resolution shall become effective at the earliest date allowed by law.
