A RESOLUTION ACCEPTING THE APPLICATION OF JOSEPH V. DESARO, SR. AND MARY F. DESARO FOR THE ANNEXATION OF TERRITORY.

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

<u>Section 1.</u> That the application of Joseph V. DeSaro, Sr. and Mary F. DeSaro for the annexation of the following described territory:

Situate in Section 5, Town 2, Range 5 M.Rs., Washington Township, Montgomery County, Ohio, being part of the 4.49 acre tract conveyed to Joseph V. DeSaro, Sr. and Mary F. DeSaro by deed recorded in Microfiche Number 78-543D05 of the Deed Records of Montgomery County, Ohio and being a tract of land more particularly described as follows:

Starting for reference at the northeast corner of said Section 5, said corner also being in the centerline of Spring Valley Pike;

thence from said Starting Point N 67°18'02" W with the north line of said Section 5 and the centerline of Spring Valley Pike a distance of 223.56 feet to the northeast corner of the 0.224 acre tract conveyed to the Board of Trustees of Washington Township, Montgomery County, Ohio by deed recorded in MF #95-533A05;

thence S 05°19'43" W a distance of 47.08 feet to the southeast corner of said tract, said corner being on the south right-of-way line of Spring Valley Pike and the True Point of Beginning for the herein described tract to be annexed to the City of Centerville;
