We are pleased to offer this proposal for surveying services on the above referenced project. We have examined the request, reviewed information of record and visited the site. We propose to provide survey per your requirements as outlined in our conversation of yesterday. Our fees for same are as follows:

Topographical information to reconstruct ditches, including existing pipe elevations, centerline ditch elevations, erosion areas, etc. -

Bellingham ditch from north pipe to intersection (500') -- NTE------\$720.00

Lodewood ditch from Waterford to Bellingham ditch intersection (1200') ------- NTE------ \$1260.00 Hourly rates are as follows: Field \$90.00/hour, Office \$60.00/hour.

Terms and conditions:

-Date of Commencement and Duration: The date of commencement of this agreement shall be the date last appearing on the signature page. This Agreement shall remain in effect for ninety days unless terminated as provided herein, or extended by mutual agreement in writing.

-If McDougall Associates, Inc.'s services under this agreement are delayed for reasons beyond their control, the completion date specified will be modified accordingly and fees renegotiated for any unfinished services as of the effective date of such change.

-Compensation Definitions: Reimbursable costs include: fees of Professional Subcontractors (whose expertise is required to complete the project) and out of pocket expenses, the cost of which shall be charged at actual costs plus an administrative cost of 10 percent and shall be itemized and included in the invoice. Additional or extra work authorized by Client will be billed at current hourly rates of \$90.00 field and \$60.00 office.

-Invoice Procedures and Payment: McDougall Associates, Inc. shall submit invoices to the Client for Services accomplished. For services provided on a Lump Sum basis, the amount of the invoice will be determined on the percentage of completion method. Invoices shall include, separately listed, any charges for services for which time costs or unit prices shall apply.

The Client, as owner or authorized agent for the owner, hereby agrees that payment will be made for services invoiced within thirty days from the date of the invoice; and, in default to such payment hereby agrees to pay all costs of collection, including reasonable attorney fees, regardless of whether legal action is initiated. The Client hereby acknowledges that unpaid invoices shall accrue interest at 18 percent per annum after they have been outstanding for thirty days. If an invoice remains unpaid for sixty days after the date of the invoice, McDougall Associates, Inc. may, upon giving written notice of its intent to do so, suspend all services on the clients project. This suspension shall remain in effect until all unpaid invoices are paid in full. If an invoice remains unpaid ninety days after the date of the invoice, McDougall Associates, Inc. may, after giving written notice of its intent to do so, terminate this agreement and pursue remedies for collection.

-Cost Estimates: Client hereby acknowledges that McDougall Associates, Inc. cannot warrant that estimates of probable construction or operating costs provided by McDougall Associates, Inc. will not vary from actual costs incurred by the Client.

-Limit of Liability: The limit of liability of McDougall Associates, Inc. to the Client for any cause or combination of causes resulting from the Services hereunder rendered shall be, in total amount, limited to the fees paid under this agreement.

-Insurance: McDougall Associates, Inc. shall at all times carry, on all operations hereunder, worker's compensation insurance, public liability and property insurance, and automotive public liability and property damage insurance.

-Assignment: Neither the Client nor McDougall Associates, Inc. will assign or transfer its interest in this agreement without the written consent of the other. McDougall Associates, Inc. does reserve the right to subcontract any portion of the services.


