A RESOLUTION IN SUPPORT OF THE RECOMMENDATIONS OF THE AIRCRAFT NOISE TASK FORCE AND ORDERING THE TRANSMITTAL OF THE TASK FORCE REPORT TO THE APPROPRIATE PUBLIC OFFICIALS AND COMMENDING THE CITIZENS, THE FAA-DIA, AND THE OFFICIALS OF AIRBORNE EXPRESS, AS WELL AS THE APPOINTED CITIZENS OF THE AIRCRAFT NOISE TASK FORCE FOR THEIR ASSISTANCE IN DEVELOPING THIS COMPREHENSIVE APPROACH TO HELP MITIGATE ENVIRONMENTAL IMPACTS ASSOCIATED WITH THE NIGHTTIME AIR FREIGHT INDUSTRIES OPERATING IN OUR REGION.

WHEREAS, on June 20, 1996, the Federal Aviation Administration made a route change for air freight carriers, and

WHEREAS, said route change caused citizen concern due to intrusive and repetitive noise during the nighttime hours in Centerville, and in the unincorporated area of Washington Township; and

WHEREAS, as a result of these voiced concerns, the Centerville City Council and the Washington Township Trustees resolved to establish a joint aircraft noise task force to study the problem and to develop recommendations; and

WHEREAS, the Council of the City of Centerville has recognized that the citizens, air freight carrier officials, the local Federal Aviation Administration and our local government employees have provided reasonable and regionally based recommendations as presented in their initial approach to refine flight paths, to encourage additional research and to call for regulatory reform.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the Members of the Aircraft Noise Task Force, the local FAA office and Airborne Express are hereby commended for their

cooperative roles in fact finding and developing recommendations to mitigate the environmental impact of aircraft noise as experienced by our citizens since the June 20, 1996 route change.

- Section 2. That the Clerk of this Council is hereby authorized and directed to cause certified copies of this Resolution to be prepared and transmitted to the citizen volunteers serving the Aircraft Noise Task Force.
- Section 3. That the Clerk of this Council is also hereby directed to cause copies of the Aircraft Noise Task Force Report to be transmitted to all appropriate public officials on behalf of the City Council and Township Board of Trustees as an official JOINT request for improved noise abatement practices and procedures on behalf of all the citizens of Centerville and Washington Township.
