A RESOLUTION ACCEPTING THE OFFER OF MIAMI VALLEY CABLE COUNCIL TO SPONSOR A NEW SYSTEM WHICH PLACES PERSONAL COMPUTERS IN POLICE CARS, AND PROVIDE A CERTAIN NUMBER OF COMPUTERS AND RELATED SOFTWARE AND SUPPORT SERVICES TO THIS CITY.

WHEREAS, new technologies make it economically feasible to provide personal computers in police cars with direct links to various criminal intelligence data bases such as LEADS and NCIC; and

WHEREAS, Miami Valley Cable Council (MVCC) has offered to underwrite much of the cost of providing and operating such a system on behalf of its member cities; and

WHEREAS, there are many benefits to be derived from instituting such a system, including better service to the public, improved Officer safety, increased effectiveness and efficiency of police work, and the prospect of linkages to other related technologies such as, computer assisted dispatch, global positioning satellites and computer based report generation and archiving; and

WHEREAS, the proposed system will, for the first time, provide a direct communications link between all MVCC member cities with attendant.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

- Section 1. That the support preferred by Miami Valley Cable Council in their Resolution number 97-3 is hereby accepted.
- Section 2. That in accepting this offer we acknowledge that there may be some costs involved, such as monthly communications service fees, or the acquisition or installation of additional units beyond the first three to be provided under the terms of MVCC's offer and we agree to provide funds to cover those costs.

- Section 3. That since the proposed system is a cooperative effort among nine cities, which may require agreement on new standards of resolution of differences among us, we commit to work with MVCC and the other police agencies in good faith to create a universal, common standard which will permit full participation in the benefits of this new technology by all the included cities.
- Section 4. That the initial work in identifying and adopting this new technology was done by the City of Kettering Police Department, and they will continue to act on behalf of all participants in writing specifications, bidding and other negotiations with vendors. This Resolution authorizes participation in any joint bidding by this City in the process of purchasing goods or services needed to put this system into effect.
- <u>Section 5.</u> That the City Manager and Police Chief are hereby authorized and directed to take whatever steps are necessary to make this city a full participant in and beneficiary of this offer made by MVCC.

Section 6. This Resolution shall become effective at the earliest date allowed by law.
