A RESOLUTION AUTHORIZING AND DIRECTING THE CITY
MANAGER TO EXECUTE A SUPPLEMENT TO THE
AGREEMENT BETWEEN THE CITY OF CENTERVILLE AND
ALTICK & CORWIN, DATED JULY 1, 1991.

WHEREAS, the City of Centerville has legal authority to secure such legal and
consulting services as may be desirable for the general operations of the City, and


WHEREAS, the Agreement between the City of Centerville and Altick and
Corwin for legal and consulting services, dated July 1, 1991, requires a Supplement for
an adjustment in the schedule for compensation for Altick and Corwin.

RESOLVES:

SECTION 1. That the City Manager is hereby authorized and directed to execute a
Supplement to the Agreement between the City of Centerville and Altick & Corwin, a
copy of which is attached hereto, marked Exhibit "A" and incorporated herein.

SECTION 2. This Resolution shall become effective at the earliest date allowed
by law.

SUPPLEMENT TO AGREEMENT

A supplement to an Agreement made and entered into the 1st day of July, 1991 by and between the City of Centerville, an Ohio Municipal Corporation, hereinafter called the "City", and Altick & Corwin, a law partnership of Dayton, Ohio, for the furnishing of legal and consulting services by Altick & Corwin to the City, as may be requested by the City Manager or other authorized representative of the City.

- 1. That compensation by the City to Altick & Corwin be supplemented by changes outlined in the following schedule:

July, 1991 through December 31, 1991	\$75.00/hour
January 1, 1992 through December 31, 1993	\$85.00/hour
January 1, 1994 and thereafter until amended	\$95.00/hour
