A RESOLUTION ACCEPTING THE BID FROM AKZO SALT, INC., AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH AKZO SALT, INC., FOR THE PURCHASE OF HIGHWAY ROCK SALT FOR SNOW AND ICE CONTROL FOR 1997 FOR THE CITY OF CENTERVILLE, OHIO.

WHEREAS, the Southwest Ohio Purchasers for Government (SWOP4G) advertised for bidders for Highway Rock Salt pursuant to specifications prepared by SWOP4G; and

WHEREAS, SWOP4G accepted bids from Akzo Salt, Inc., North American Salt Company, Cargill, Inc., and Morton International, Inc., for the purchase of highway rock salt; and

WHEREAS, Akzo Salt, Inc., is the low and best bidder for the City of Centerville, Ohio.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

<u>Section 1.</u> That the bid submitted by Akzo Salt, Inc., for the purchase of highway rock salt according to the specifications marked exhibit "A" attached hereto and made a part hereof, is hereby accepted for the purchase price of \$30.25 per ton, plus \$1.50 per ton piling charge.

<u>Section 2.</u> That the City Manager is hereby authorized and directed to enter into any necessary agreement to evidence acceptance of said bid and to make payment pursuant thereto.

Section 3. This Resolution shall become effective at the earliest date allowed by law.



SUBJECT: BID TABULATION FOR ROCK SALT

Enclosed please find a bid tabulation for the rock salt bid opened Tuesday of this week. This has been a very difficult bid to evaluate this year. Bids were all over the board - a few were lower, but most were higher. We averaged a \$1.33 increase in salt prices this year. Akzo was the apparent low bidder on 135,500 Tons, with North American taking 18,050 Tons, Morton taking 7,350 Tons and Cargill taking 7,200 Tons. These numbers do not include piler charges, which will make a difference since North American charged a higher amount (\$2.00 vs. \$1.50 charged by the other bidders).

I am recommending each entity make the award to the company giving the lowest and best price for that entity. When determining lowest and best bid, be sure to note piler charges, as well as the minimum deliveries (see last page of bid tab). You will need to choose the lowest and best bidder for your entity and make your own award, using your normal award process (purchase order, letter of intent, etc.). Be sure to also note on your order whether you need a piler with your delivery. As in the past, your orders need to reference the SWOP4G bid coordinated by the City of Middletown. Also, please be sure to let me know with which company you placed your order. If you award to other than the low bidder on the bid tab (also considering the piler charges and minimum deliveries), please call me to discuss before you place your order - the integrity of the bid rests on placing orders with the lowest bidders. You can mail me a copy of your purchase order, drop me a handwritten note, or fax a copy of your purchase order to me at 513-425-1830. I did not mail complete copies of the bid due to the mailing costs involved. If your entity requires a complete copy, please let me know and I'll send one out.

We were late bidding salt this year since we were waiting on the State to bid. Waiting longer than usual did not appear to hurt us this year, since the majority of the State prices were higher than our bid. Our tonnage this year was less than last year, due to the fact that one of the larger entities cut their order in half. We had 70 entities participate this year (up from 69 last year), bidding a total of 168,100 Tons of salt, which represents well over \$5 million in salt.

As a side note, you may be aware that Cargill is in the process of purchasing Akzo. The sale should be completed by the end of this year. This did not appear to affect our bids this year, but puts next year's bids on a whole new playing field since we'll be down to only three bidders.

Please be sure to keep me informed of any problems you have throughout the season. I can be reached at 513-425-7832. Hopefully, this winter will be extremely mild, and we won't have any of the problems we've experienced in the past. Keep your fingers crossed!
