

RESOLUTION NO. 16-95
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER Sell, Beals ON THE 21st DAY
OF February, 1995.

A RESOLUTION AUTHORIZING THE PURCHASE OF SIX MOTOROLA
PORTABLE RADIOS FOR PLAIN CLOTHES POLICE OFFICERS WITHOUT
COMPETITIVE BIDDING.

WHEREAS, the Centerville Police Department presently operates on a Motorola trunked
800 megahertz radio system with trunk capabilities; and

WHEREAS, the great majority of the Police Department radios operate in the trunked
mode; and

WHEREAS, the 1995 police budget has provided for the purchase of six additional
portable radios with a securenet (scrambled feature) for all police plain clothes officers; and

WHEREAS, the only manufacturer capable of supplying the six additional portable radios
is Motorola which this council hereby finds is the sole source of radio equipment which is
compatible with the existing system even though other manufacturers do produce 800 megahertz
radio systems; and

WHEREAS, this council further finds that since Motorola is the sole source of
compatible radio equipment, competitive bidding would be a useless act and would not benefit
the City and its citizens;

NOW, THEREFORE,

THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the Police Department of the City of Centerville is hereby
authorized to purchase the following described equipment without competitive bidding for the
reason that Motorola is the sole source of radio equipment which is compatible with the existing
radio equipment owned by the Centerville Police Department:




