AGREEMENT

- A. GT and the City have entered into a certain Agreement dated June 27, 1994 (the "Purchase Agreement"). All capitalized terms contained herein shall have the same meanings assigned to such terms by the Purchase Agreement.
- B. GT and the City desire to commence the construction work necessary to extend a water main along Yankee Road for the benefit of the Project prior to the Initial Closing, and GT is willing to initiate such construction prior to the Initial Closing upon the terms and conditions contained in this Agreement.

NOW, THEREFORE, in consideration of the mutual agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, GT agrees to construct and install the extension of the water main along Yankee Street as necessary to serve the Project and to initiate such construction and installation promptly upon the execution of this Agreement and the City agrees that, if the Initial Closing does not occur and the Purchase Agreement is terminated, then the City shall promptly, upon the request of GT, reimburse GT for all of its costs and expenses incurred as a result of the construction and installation.
