

RESOLUTION NO. 59-94  
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER JAMES SINGER ON THE  
17th DAY OF OCTOBER 1994.

A RESOLUTION SUPPORTING THE SLOGAN "BIRTHPLACE OF AVIATION" BEING PLACED ON OHIO LICENSE PLATES ALONG WITH AN APPROPRIATE SYMBOL REPRESENTING AVIATION.

WHEREAS, the State of Ohio is truly the "Birthplace of Aviation" demonstrated by its rich history of aviation invention and development including:

1. The design, construction and flight of the first airplane in Dayton, the home of the Wright Brothers.
2. The construction of personal and airline aircraft, including engines, in Cincinnati,
3. The construction of WACO planes in Troy,
4. The development of aviation fuels in Findlay.
5. The design, development and construction of aircraft instruments, generators, starters and related products in Cleveland,
6. The design and construction of dirigibles and blimps in Akron, and
7. The development of the first night aerial photography capability; and

WHEREAS, the State of Ohio remains the birthplace of modern aviation with Dayton the home of Wright Patterson Air Force Base and Laboratories, Cambridge the home of John Glenn, the first man to orbit the earth, Wapakoneta the home of Neil Armstrong, the first man to land on the moon, and Cleveland the home of the National Aviation and Space Association; and

WHEREAS, the slogan "Birthplace of Aviation" will not only be a continual expression of the pride the Citizens of Ohio have in their State, but also will be motto with National significance, bringing well deserved recognition to our State.


NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY


