WHEREAS, A to Z Landscaping was the lowest and best bidder for parcels 1, 2, 4, 6, 7, and 8; and


WHEREAS, Harlow's Landscaping was the lowest and best bidder for parcels 3, 5, 9, 10, and 11.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:


