A RESOLUTION OF SUPPORT TO PETITION GEORGE BUSH, PRESIDENT OF THE UNITED STATES, TO SUSPEND ALL ACTIVITIES BY THE DEPARTMENT OF ENERGY REGARDING THE RECONFIGURATION OF THE NUCLEAR WEAPONS COMPLEX UNTIL A COMPLETE REVIEW OF DOE CONSOLIDATION PLANS IS COMPLETED.

WHEREAS, EG&G Mound Applied Technologies has been a responsible corporate citizen in the Miami Valley; and

WHEREAS, the people who have worked at this site have, for over 40 years, managed their stewardship of the local environment faithfully and effectively for the protection of all citizens; and

WHEREAS, the employees of Mound have been actively involved in the improvement of the quality of life in our communities, schools, major social programs, and made significant contributions to the technical resources of our region and the State of Ohio; and

WHEREAS, Mound employees have contributed to the defense of our country and its way of life; and

WHEREAS, we request that the U.S. Department of Energy re-evaluate the conclusions set forth in the non-nuclear consolidation plan to include greater insight and analysis into the benefits that will be derived by retaining the Mound facility and its employees at its present location.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES THAT:

SECTION 1. The Mayor, City Council and citizens of the City of Centerville do hereby express their deepest concern and objections to the Department of Energy's preliminary decision to close the Mound Plant in its consolidation of the nuclear weapons complex.

SECTION 2. The City of Centerville expresses its support for the proposal that an independent commission be created to review the Energy Department's consolidation proposals and future decisions to close Energy Department plants.

SECTION 3. This Resolution shall take effect at the earliest date allowed by law.
