SPONSORED BY COUNCILMEMBER J. V. Stone ON  
THE 14th DAY OF April 1992.

A RESOLUTION ACCEPTING THE RETIREMENT OF  
DARRYL K. KENNING AS CITY MANAGER AND  
PROVIDING FOR AN ORDERLY TRANSITION.

WHEREAS, Darryl K. Kenning has served as City  
Manager of the City of Centerville since 1974; and

WHEREAS, he has advised the Council of the City of  
Centerville of his desire to retire as City Manager of  
Centerville effective May 1, 1992; and

WHEREAS, the Council of the City of Centerville  
feels it is in the best interest of the City and Darryl K.  
Kenning that the terms of his retirement as city Manager be  
set forth in writing and legislatively adopted by the City  
Council;

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE  
HEREBY RESOLVES:

SECTION 1. That the retirement of Darryl K.  
Kenning as the City Manager of the City of Centerville is  
hereby effective June 11, 1992.


SECTION 2. That Darryl K. Kenning take all accrued  
but unused vacation after May 1, 1992.

SECTION 3. That in accordance with a previous  
managerial agreement at the time of Darryl K. Kenning's  
hiring in 1974 which is verified in writing by Mr. Paul Hoy,  
who was Mayor at that time and represented the City Council,  
that Darryl K. Kenning's sick leave days could be accrued  
until his retirement (Exhibit I attached).


SECTION 4. That a lump sum payment for accrued  
sick leave days to be paid in three equal monthly  
installments with the first of said installments being due on  
June 1, 1992 and the remaining being payable on the first day  
of each month thereafter until paid in full (Exhibit II  
attached).

SECTION 6. That Darryl K. Kenning be available to assist in the orderly transition of the City to new City management up through and including June 11, 1992.
