

Washington Township -- a certified check or bidding bond in the amount of ten percent (10%) of the bid must accompany this proposal.

City of Centerville -- the bid must be accompanied by a bid bond of five percent (5%) of the bid amount. The successful bidder shall furnish a 50% Performance Bond.

The bid proposals will remain firm for acceptance for thirty (30) days after the bid opening unless otherwise stated.

The above items shall be bid, removed, replaced, performed and adhered to according to the State of Ohio Department of Transportation "Construction and Material Specification" manual, latest edition. Any and all items shall be constructed according to such specifications and will be the responsibility of the successful bidder to perform accordingly.

The undersigned hereby certifies that the materials and equipment furnished as a result of this bid will be in full accordance with the State of Ohio and the attached Washington Township Supplemental Specifications.
